

RESOLUTION NO. 2020 – 27

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING
THE TAX ASSESSOR FOR THE TOWNSHIP OF LITTLE EGG
HARBOR TO FILE CERTAIN APPEALS ON BEHALF OF THE
TOWNSHIP AND ALSO DESIGNATING THE TAX ASSESSOR AS
AGENT IN FILING PETITION OF APPEALS AND ROLL-BACK
COMPLAINT FORMS**

WHEREAS, from time to time, the Tax Assessor discovers an error in calculations, transposing, measurement, or typographical errors in the tax assessment on the tax list after the time the Ocean County Board of Taxation has certified the tax assessments for the year, tax rates for the year or a property becomes subject to a roll-back assessment; and

WHEREAS, the governing body of the Taxing District of Little Egg Harbor Township is desirous that every taxpayer pays his fair share of taxes; and

WHEREAS, if the above discovered errors are not corrected or a roll-back assessment not applied, the taxpayers affected would not be paying their fair share of taxes; and

WHEREAS, the method for correcting such errors is to file a Petition of Appeal for the current year or Complaint with the Ocean County Board of Taxation.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the Tax Assessor is hereby authorized to act as the agent for the Taxing District of Little Egg Harbor Township, and to file a Petition of Appeal or Complaint for the current year with the Ocean County Board of Taxation to correct any erroneous assessments to the proper value.

2. That the Tax Assessor is hereby authorized to file farmland assessment rollback complaints against any formerly qualified farmland properties for the 2018 and 2019 tax years.


3. That the Tax Assessor and Municipal Attorney are hereby authorized to execute stipulation of settlement on any tax appeal or complaint filed by the Taxing District or by a taxpayer in the tax year 2020.

4. That a copy of any Petition of Appeal or Complaint filed with the Ocean County Board of Taxation under this Resolution be filed with the Municipal Clerk.

5. That a certified copy of this Resolution be forwarded to the Ocean County Board of Taxation and the Little Egg Harbor Township Tax Assessor.
