

RESOLUTION NO. 2020-90

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING THE ANNUAL BUDGET OF LITTLE EGG HARBOR FIRE DISTRICT NO. 2, IN ACCORDANCE WITH N.J.S.A. 40A:14-78.5**

**WHEREAS**, at the annual election held on February 15, 2020, the question of the final adoption of the annual budget of Little Egg Harbor Fire District No. 2, in the Township of Little Egg Harbor, was voted negatively upon by the majority of legal voters voting in the election; and

**WHEREAS**, in accordance with N.J.S.A. 40A:14-78.5, the governing body of the Township of Little Egg Harbor conducted a Public Hearing for which the legal voters of the Fire District were given five (5) days' advertised notice, at which any interested person was heard; and

**WHEREAS**, subsequent to the Public Hearing, the governing body, by a resolution of a majority of its full membership, shall now fix an annual budget for the Fire District, which must be within thirty (30) days after the annual election; and

**WHEREAS**, it is the desire of the governing body to fix the annual budget such that the amounts of each appropriation section of the budget so fixed either do not exceed the amount for each as previously voted upon at the annual election, or are reduced, except the appropriation for debt service which shall be included in the amount that is required to be paid, in accordance with State law.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:
