

RESOLUTION NO. 2021 – 112

**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AUTHORIZING THE EXECUTION
OF A MUNICIPAL SERVICES AGREEMENT WITH
QUALIFIED PRIVATE COMMUNITIES**

WHEREAS, N.J.S.A. 40:67-23.5 provides that a municipality shall enter into a written agreement to annually reimburse a qualified private community in an amount not to exceed the cost that would be incurred by the municipality in providing these services directly for the removal of snow and ice, lighting of the roads and streets, the collection of leaves and recyclable material, and the collection and disposal of solid waste along the roads and streets; and

WHEREAS, the communities delineated on the attached Schedule A represent that each is a qualified private community pursuant to N.J.S.A. 40:67-23.2, and is thereby subject to the provisions of N.J.S.A. 40:67-23.3; and

WHEREAS, the Township desires to execute a municipal services agreement with the communities delineated on the attached Schedule A to provide for the reimbursement of certain services.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Township is authorized to execute an agreement with each of the communities delineated on the attached Schedule A for the reimbursement of municipal services, in accordance with N.J.S.A. 40:67-23.5.

2. That the Mayor is authorized to execute, and the Municipal Clerk to attest to, the municipal services agreements with each of the communities delineated on the


