

RESOLUTION NO. 2021 – 114

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING USE OF TOWNSHIP PROPERTY FOR ATLANTIC CITY REGIONAL STAND DOWN FOR VETERANS: MOBILE ON MAY 28, 2021

WHEREAS, the Office of the Director, Wilmington VA Medical Center, Veteran Community Outreach Team, Atlantic/Cumberland County Outpatient Clinics (hereinafter “Wilmington VA Medical Center”), has requested the use of municipally owned property, namely the outside area at 7 Gifford Road, to hold the Atlantic City Regional Stand Down: Mobile (ACRSD:M) for veterans; and

WHEREAS, due to the COVID-19 pandemic, the Atlantic City Regional Stand Down: Mobile (ACRSD:M) needs to be conducted in a mobile version instead of at the All Wars Memorial Building in Atlantic City; and

WHEREAS, the ACRSD:M allows the Wilmington VA Medical Center to reach veterans who may need assistance; and

WHEREAS, the governing body desires to grant permission to the Wilmington VA Medical Center for the ACRSD:M event to be held on May 28,2021 from 11:00 a.m. to 2:00 p.m. and in accordance with the terms and conditions herein.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby grant permission to the Wilmington VA Medical Center for the ACRSD:M event to be held in the outside area of 7 Gifford Road, on May 28, 2021, between the hours of 11:00 a.m. and 2:00 p.m., subject to the conditions delineated below:



- a. Wilmington VA Medical Center shall provide the following to the Township Administrator, by May 21, 2021:
 - i. A contact name and phone number for the Team, who will be able to be reached on the day of the event.
 - ii. Estimated size of attendance.
 - iii. Description of the activity or event.
 - iv. Description of the manner in which the Team shall comply with current Executive Orders and other directives, including CDC guidelines, as to social distancing and screenings.
 - v. A valid certificate of insurance, in an amount of coverage satisfactory to the OCJIF, naming the Township of Little Egg Harbor as an additional insured.
 - vi. A fully-executed Indemnification and Hold Harmless Agreement, in a form acceptable to the Township Attorney, by the responsible entity.
2. That a certified copy of this resolution be forwarded to the interim Township Administrator and Patrick Carney, Wilmington VA Medical Center.
