**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY  
AUTHORIZING THE PURCHASE OF A 2022 FORD F350  
4WD PICKUP TRUCK UNDER STATE CONTRACT

**WHEREAS**, the Little Egg Harbor Department of Public Works is in need of a 2022 Ford F350 4WD Pickup Truck; and

**WHEREAS**, the Township is able to purchase the pickup truck under State Contract A88758, T2101 from Winner Ford without the need for formal bidding; and

**WHEREAS**, Winner Ford provided a proposal via email dated April 8, 2021 for \$40,614.00 to provide a 2022 Ford F350 4WD Pickup Truck; and

**WHEREAS**, it is the desire of the governing body to award a contract for the 2022 Ford F350 4WD pickup to Winner Ford pursuant to State Contract A88758, T2101.



1. That the governing body does hereby award a contract for a 2022 Ford F350 4WD pickup truck to Winner Ford pursuant to State Contract A88758, T2101 at an amount not to exceed \$40,614.00, in accordance with the proposal submitted via email on April 8, 2021.
  2. That the Mayor is authorized to execute and Municipal Clerk to attest to a contract with Winner Ford in accordance with said proposal.


