

**RESOLUTION NO. 2021 – 149**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE APPOINTMENT OF SUSAN FARRELL AS TEMPORARY REGISTRAR OF VITAL STATISTICS**

**WHEREAS**, upon the retirement of the Municipal Clerk, who also performed the duties of the Registrar of Vital Statistics, the position of Registrar has been vacant since July 1, 2021; and

**WHEREAS**, if in case of such vacancy, the appointing authority shall within 10 days thereafter fill such vacancy and certify the same to the State department, the department may make such appointment, and in the meantime the clerk of the appointing authority shall act as local registrar pursuant to N.J.S.A. 26:8-15; and

**WHEREAS**, while it is the intent that whoever shall become the new Municipal Clerk will also perform the duties of Registrar of Vital Statistics, that position is unfilled and therefore, the vacancy must be filled temporarily by the Township so that the State Registrar does not make such appointment; and

**WHEREAS**, Susan Farrell has the requisite qualifications for the position; and

**WHEREAS**, the governing body desires to appoint Susan Farrell, as Temporary Registrar of Vital Statistics for a period of three (3) months, or until the appointment of a Municipal Clerk qualified to perform the duties of Registrar of Vital Statistics, whichever occurs first.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey:

1. That Susan Farrell is appointed to the position of Temporary Registrar of Vital Statistics, for a period of three (3) months, or until the appointment of a Municipal Clerk qualified to perform the duties of Registrar of Vital Statistics, whichever occurs first.
2. That a certified copy of this Resolution shall be forwarded by the Municipal Clerk to the State Registrar, interim Township Administrator, and Susan Farrell.


