**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING PARTICIPATION IN THE STATE GRANT PROGRAM, SFY21 BODY-WORN CAMERA GRANT PROGRAM AND ACCEPTING STATE FUNDS**
