**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY,
AUTHORIZING ASSIGNMENT OF TAX SALE
CERTIFICATE #16-00096**

WHEREAS, N.J.S.A. 54:5-113, authorizes assignment by a municipality of Tax Sale Certificates for the full amount of the certificate, including all subsequent municipal taxes and other municipal charges: and,

WHEREAS, Olive Enterprises, LLC, has presented an offer to purchase, by assignment, Certificate of Sale #16-00096 which was issued to the Township of Little Egg Harbor at a tax sale held December 13, 2016, on Block 284, Lot 2, known as Otis Bog Rd., Little Egg Harbor, NJ and assessed to Tuckerton Mortgage, in the amount of \$57,342.15, being the full amount of the certificate, including all subsequent municipal taxes and other municipal charges.
