**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AUTHORIZING ASSIGNMENT OF TAX SALE  
CERTIFICATE #18-00075**

**WHEREAS**, N.J.S.A. 54:5-113, authorizes assignment by a municipality of Tax Sale Certificates for the full amount of the certificate, including all subsequent municipal taxes and other municipal charges; and

**WHEREAS**, Olive Enterprises, LLC, has presented an offer to purchase, by assignment, Certificate of Sale #18-00075 which was issued to the Township of Little Egg Harbor at a tax sale held December 19, 2018, on Block 283, Lot 2, known as Otis Bog Rd., Little Egg Harbor, NJ and assessed to Tuckerton Mortgage, in the amount of \$706.94, being the full amount of the certificate, including all subsequent municipal taxes and other municipal charges.
