

**RESOLUTION NO. 2021 -264**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (DAVID DEAN, BLOCK 285.01, LOT 27)**

**WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and**

**WHEREAS, it has been determined by the Tax Assessor that property known as Block 285.01, Lot 27, owned by David Dean, qualified for a Veterans' Property Tax Exemption in the year 2021; and**

**WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and**

**WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$643.28; and**

**WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2021 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and**

**WHEREAS, the Tax Collector deems that the mortgage company, Corelogic, receive a refund on taxes already paid for the year 2021 in the amount of \$393.28.**

**NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:**

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$643.28 for the year 2021 for Block 285.01, Lot 27, owned by David Dean, and authorize a refund to the mortgage company, Corelogic, in the amount of \$393.28.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, David Dean, Corelogic and the Chief Financial Officer.
