RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING REIMBURSEMENT OF SICK LEAVE TO EMPLOYEES FOR COVID 19 EXPOSURE AT TOWNSHIP BUILDING

WHEREAS, the paid sick leave provisions of the federal Families First Coronavirus Response Act (FFCRA) expired December 31, 2020; and

WHEREAS, a COVID-19 exposure at the Township Construction Department resulted in eight (8) Township employees being directed to leave work and quarantine in accordance with CDC guidelines; and

WHEREAS, said employees would have been entitled to paid sick leave under the FFCRA based on the circumstances of COVID-19 exposure; and

WHEREAS, the Township Committee wishes to authorize reimbursement to the employees listed on the attached Schedule A, for the PTO used as a result of the Township's directive to leave work and remain out for the balance of the quarantine period after the COVID 19 exposure at the Township during work hours.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the reimbursement for sick leave taken for COVID-19 exposure at the Construction Department between January 6, 2021 and January 15, 2021 to the employees named in Schedule A attached.
2. That a certified copy of this resolution shall be forwarded to the Township Administrator, Chief Financial Officer and the employees listed on attached Schedule A.
