

RESOLUTION NO. 2020-108

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING BARNEGAT BAY PARTNERSHIP TO CONTINUE MONITORING THE IOWA COURT LIVING SHORELINE PROJECT

WHEREAS, the Township of Little Egg Harbor submitted an application for a Coastal GP 24 for a project entitled “Little Egg Harbor/Tuckerton Marsh Resiliency Project”; and

WHEREAS, the goal of the Coastal GP 24 is to create a living shoreline within the area of Iowa Court that will re-establish a portion of the shoreline back to the 1977 tidelands claim line; and

WHEREAS, the project has been constructed and, pursuant to the NJDEP WQR319h Grant the Township received for this project, post-construction monitoring is required; and

WHEREAS, on March 12, 2020, the governing body adopted Resolution 2020-81, which authorized “Save Barnegat Bay” as monitor, and the correct name should be “Barnegat Bay Partnership”; and

WHEREAS, Barnegat Bay Partnership will be performing the required monitoring on behalf of the Township, through Ocean County College; and

WHEREAS, it is the desire of the governing body to authorize Barnegat Bay Partnership to monitor the Iowa Court Living Shoreline Project on behalf of the Township, in conformance with NJDEP standards and the scope of work they provided, attached hereto as Schedule “A”.
