RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR THE FY 2019 MUNICIPAL AID ROAD PROGRAM – IMPROVEMENTS TO IOWA COURT TO COMMAND COMPANY, INC.

WHEREAS, the Township of Little Egg Harbor duly advertised for the receipt of bids for the FY 2019 Municipal Aid Road Program – Improvements to Iowa Court; and

WHEREAS, in response to the invitation to bidders, four (4) bids were received on May 7, 2020; and

WHEREAS, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined that Command Company, Inc. submitted the lowest responsible and responsive bid in accordance with the bid specifications, said bid being \$445,314.00; and

WHEREAS, it is the desire of the governing body to award a contract for the FY 2019 Municipal Aid Road Program – Improvements to Iowa Court to Command Company, Inc, said award being subject to the review and approval of the New Jersey Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby award a contract to Command Company, Inc, the lowest responsible and responsive bidder, for the FY 2019 Municipal Aid Road Program – Improvements to Iowa Court in the amount of \$455,314.00, said award being subject to the review and approval of the New Jersey Department of Transportation.
