Dr. John Edmunds of Spruce Drive: Updated the Mayor and Committee Members on Tuckerton Borough's Council meeting that took place on Monday, February 7, 2022.

Danielle Kelly: Stated there are several issues that are occurring within Pinelands Regional School District and she requested a meeting with the Mayor and the Interim Business Administrator to discuss what is taking place within the district.

Mayor Kehm stated he was not aware of any issues and would like to meet and discuss.

Mr. Art Mooney of Windstar Drive: Asked for an update on the bus shelter and American Rescue Plan.

Interim Business Administrator/CFO, Rodney Haines stated the bus shelter will be done with funds from this years budget and all bus shelters are on the Townships Insurance policy in case of future accidents.

Mayor John Kehm explained to Mr. Mooney that there are several funding opportunities available and he needs to ensure that the Township gets the most out of the money that is out there and available.

Township Engineer Jason Worth reiterated the amount of money that is out there and the Township wants to make sure that the funds are spent appropriately and not frivolously just to spend the money.

Andrea Dinkowitz of Atlantis Blvd: Requested for a light to be installed due to the lack of visibility while making a left hand turn onto Radio Road from Country Club Blvd due to the bend in the road. She stated the vehicles are speeding, golfers are crossing and there have been multiple accidents at that intersection due to the lack of visibility.

Mayor Kehm asked the Township Engineer if a traffic study can be done.

Township Engineer Jason Worth stated he will follow-up with the County. He stated he did send information to the County on this and he is waiting to hear back from them.

TOWNSHIP ENGINEER COMMENTS

Township Engineer Jason Worth stated the Sports Complex field rehabilitation is near completion with a date of Mid-May that the project will be complete. He stated that Mystic Island Drainage and Roadway Improvements Phase 2 is complete except for final surface course paving which should be complete by Spring. He also stated Ocean County is having their annual meeting, which he has a list of things that he needs updates on. He also stated if anyone would like to bring any County concerns or projects to his attention he will provide them with their attention as well.

TOWNSHIP COMMITTEE COMMENTS

Committeeman Daniel Maxwell stated he administered the oath of office to the fire officers of the Mystic Island Volunteer Fire Company on Friday, February 4 and thanked them for the opportunity. He thanked the Department of Public Works for all their dedicated time and work during the winter storm last weekend. Also, he stated the Senior Advisory Board will be meeting on Monday, February 28 at 10am at the Community Center.

Committeeman Ray Gormley provided an update on the dredging projects and stated the third phase of the dredging projects will soon be underway. He stated a meeting will be held on March 19 to provide the public with full details of the project. He stated postcards will go out to property owners in the upcoming weeks. He stated in order to enter the meeting, the postcard must be in hand by only one resident per property.

Committeeman Kenneth Laney wished everyone a Happy Valentine's Day and thanked staff for transitioning him smoothly into the position.

Deputy Mayor Scibetta spoke regarding the Township wide Environmental Commission clean-up event that is being held on April 9 which includes food, drinks, a t-shirt and seedlings which will be passed out for Arbor Day. He stated sign-ups are online for the clean-up event. He further stated the date for National Night Out this year is August 2, 2022, Little Egg Harbor Chamber of Commerce Harvest Fest event will be held on October 22, 2022 and the annual August Fest will be on October 28, 2022. Lastly, he stated Spring registration is now open for PAL Soccer sign-ups. He wished everyone a Happy Valentine's Day.

Mayor John Kehm thanked Department of Public Works as well as all Police, Fire and EMS for all the hard work, time and dedication that is provided everyday but especially during the last winter storm. He stated there has been several complaints regarding leaf clean-up in town and residents need to only provide leaves in a pile for pick-up. He stated the trucks have been needing several repairs due to residents throwing stumps, blocks and other materials into the leaf piles causing the machines to break. He reiterated leaf pick-up is for only leaves and there is a possibility that home owners may need to start bagging their own leaves and bringing them to the DPW yard, like it was done in the past. He stated staff needs to come up with a plan because it is costing the town too much money due to the maintenance on the trucks. He further wished residents and staff a Happy Valentine's Day.
