ORDINANCE NO. 2022-04

AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, VACATING ALL RIGHTS, TITLE AND INTEREST TO AN EXISTING EASEMENT UPON BLOCK 325.113, LOT 1 ALSO KNOWN AS 17 WALKILL ROAD AND ACCEPTING A NEW 10.00' WIDE STORM DRAINAGE EASEMENT ACROSS SAID PROPERTY

WHEREAS, the "Final Map of Great Bay Estates, Section 4-E, Little Egg Harbor Township, Ocean County, New Jersey" filed in the Ocean County Clerk's Office on March 19, 1971 as Map No. G-78 shows a 10.00' wide storm drainage easement across Block 325.113, Lot 1; and

WHEREAS, Map No. G-78 indicates an inaccurate location of the easement across the property, as the Township's drainage improvements are actually in a different area on the lot owned by John and Kathleen Webster; and

WHEREAS, the property owners, Kathleen and John Webster, agree to grant the Township a 10' wide Storm Drainage Easement, as indicated by the legal description prepared by Robert L. Cigol, P.L.S. of DMC Associates Inc., Land Surveyors on February 4, 2022, said legal description and survey attached to the proposed Easement (Exhibit A to this ordinance) in exchange for the Township agreeing to vacate all of the right, title and interest of the Township in any easement created pursuant to the "Final Map of Great Bay Estates, Section 4-E, Little Egg Harbor Township, Ocean County, New Jersey" filed in the Ocean County Clerk's Office on March 19, 1971 as Map No. G-78, which shows a 10.00' wide storm drainage easement across Block 325.113, Lot 1 in a different area; and

WHEREAS, this exchange of property interests is in the best interest of the Township so as to properly locate the storm drainage easement and is authorized pursuant to N.J.S.A. 40A:12-16 of the Local Lands and Buildings Law.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the Township agrees to vacate all of the right, title and interest of the Township in any easement created pursuant to the "Final Map of Great Bay Estates, Section 4-E, Little Egg Harbor Township, Ocean County, New Jersey" filed in the Ocean County Clerk's Office on March 19, 1971 as Map No. G-78, which shows a 10.00' wide storm drainage easement across Block 325.113, Lot 1.

SECTION 2. That the Township's agreement to vacate the 10.00' wide Storm Drainage Easement located on Map No. G-78 on Block 325.113, Lot 1, is specifically conditioned upon the property owners, John and Kathleen Webster, agreeing to grant a new 10' wide Storm Drainage Easement, as indicated by the legal description prepared by Robert L. Cigol, P.L.S. of DMC Associates Inc., Land Surveyors on February 4, 2022, said legal description and survey attached to the proposed Easement (Exhibit A to this ordinance), which is accepted by the Township as of the effective date of this ordinance.

SECTION 3. That the Township does hereby expressly reserve and except from the vacations all rights and privileges now possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act," P.L. 1972, c. 186, (C. 48:5A-1, et set.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley square, place or park, or any part thereof, being vacated by the provisions of this ordinance.

SECTION 4. At least one (1) week prior to the time fixed for further consideration for final passage of this ordnance, a copy hereof, together with a notice stating the introduction of the ordinance on first reading and the time and place when and where the ordinance will be considered for final passage, shall be mailed to every person whose lands may be affected by the adoption of the ordinance.

SECTION 5. The ordinance shall be published at least once in an official newspaper of the Township of Little Egg Harbor at least ten (10) days prior to the time fixed for consideration of the final passage of the ordinance.

SECTION 4. The Township Clerk, if this ordinance is adopted on final reading, shall submit a certified copy of this ordinance, together with proof of publication, to the Ocean County Clerk's Office for recording.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.

SECTION 6. A copy of Exhibit A as referenced herein shall be kept on file and made available for public inspection in the Township Clerk's Office during normal business hours.

STORM DRAINAGE EASEMENT

THIS GRANT OF EASEMENT made this _____ day of _____, 2022,

BETWEEN: JOHN & KATHY WEBSTER, 17 Walkill Rd., Little Egg Harbor Township,

Hereinafter called "Grantor,"

AND: LITTLE EGG HARBOR TOWNSHIP, a municipal corporation of the State

of New Jersey, having its principal offices located at 665 Radio Road, Little

Egg Harbor Township, NJ 08087,

Hereinafter called "Grantee,"

WITNESSETH:

That the said Grantor, for and in consideration of **ONE AND NO/100 (\$1.00) DOLLARS**, does grant and convey unto the said Grantee, its successors and assigns:

ALL that right of an easement, upon the that section of the property known as 17 Walkill Rd, Block 325.113, Lot 1 on the Tax Map of Little Egg Harbor Township being subject to the drainage easement hereinafter described. It is the intention of this easement to grant to the Grantee the right to use the Grantor's property for the purpose of a 10.00' wide storm drainage easement as delineated on the attached Schedule A (legal description) and Schedule B (map), both of which are attached hereto and incorporated herein.

Said property to be subject to the storm drainage easement lies in and along premises of the Grantor in Little Egg Harbor Township, County of Ocean and State of New Jersey and represents 300± square feet intended to be dedicated as a storm drainage easement pursuant to the Final Map of Great Bay Estates, Section 4-F, Little Egg Harbor Township, New Jersey, filed in the Ocean County Clerk's Office on March 19, 1971 as Map No. H-78.

The permanent easement hereby granted shall include all that right of perpetual easement (permanent easement) over the section of Block 325.113, Lot 1 for a drainage easement, together with the right to maintain existing drainage pipe and outfall, as well as trim, cut, and remove

therefrom any trees, underbrush, obstructions and other vegetation, structures, or obstacles within the limits of the easement.

The Grantor hereby covenants with the Little Egg Harbor Township that the Grantor is lawfully seized and possessed of the real estate above described; and that Grantor has a good and lawful right to convey it or any part thereof.

Said drainage easement shall commence on the day and year executed by the Grantors, as set forth above.

Subject to the Grantee's exercise of the rights granted herein, the Grantor may use the lands within the limits of the easement, provided that such use shall not interfere with, limit or obstruct the exercise of any rights by the Grantee.

The consideration hereinabove agreed as payment for the permanent easement is to be considered full and final payment to Grantor, their successors, assigns, tenants, lessees or anyone acting in their behalf, for the grant of the permanent easement as herein described.

This instrument contains the entire agreement between the parties. The terms of this instrument and the attached Exhibits which are made a part hereof, shall be binding upon the parties, their respective successors and/or assigns. Any oral representation or modifications concerning this instrument shall be of no force and effect. Any modification of this instrument must be in writing and must be signed by both parties.

This easement is granted conditioned upon the vacation by the Township of all rights, title and interest in one (1) existing 10' wide drainage easement indicated upon Block 325.113, Lot 1, also known as 17 Walkill Road, as noted on the "Final Map of Great Bay Estates, Section 4-E, Little Egg Harbor Township, Ocean County, New Jersey" filed in the Ocean County Clerk's Office on March 19, 1971 as Map No. G-78.

Said beginning point also being located 101.01 feet southwesterly from the point of intersection with the southwesterly R.O.W. line of Ramapo Road and running thence;
