Application for Bulk Variance

WHEREAS, RALPH FREDERICKS, whose mailing address is about to be 26 lowa Court, Little Egg Harbor, New Jersey 08087, has applied for relief pursuant to N.J.S.A. 40:55D-70(c) affecting premises located at Block 326.204, Lot 41, as shown on the Tax Map of the Township of Little Egg Harbor and otherwise known as 26 lowa Court, Little Egg Harbor, New Jersey; and

WHEREAS, a public hearing was held on said application on February 10, 2021, in the Municipal Building of the Township of Little Egg Harbor and testimony was presented on behalf of the applicant and all interested parties having been heard; and

WHEREAS, said Board having considered said application and testimony of the applicant, makes the following findings:

- 1. The application is deemed complete pursuant to the applicable provisions of the Little Egg HarborTownship Zoning Ordinance.
- 2. The property in question is located on the westerly side of lowa Court on the lagoon. Of the 0.15 acre (6,500 sf) site, 5,360 sf is upland property and 1,140 sf is located within the water. The site is currently improved with a vinyl bulkhead. The Applicant is proposing to construct a two-story, elevated single family dwelling with a garage below on pilings, an exterior landing and steps on the southerly side, sidewalk and an asphalt driveway. The site is

proposed to be serviced by public water and sewer. The existing bulkhead is to remain. The applicant requires the following variance:

A. Minimum Lot Depth to Bulkhead§15-4.14F(1)(b): where 87 FT is required and 80.44 FT is existing .

Applicant requests no other bulk variances or waivers.

- 3. The Applicant was represented by Richard M. Kitrick, Esquire
- 4. The Applicant testified that there would be no detriment to the surrounding community by the granting of this variance relief which would, in applicant's opinion, constitute a benefit to the neighborhood without being inconsistent with the zone plan and zoning ordinances.
 - 5. No person appeared in opposition to the subject application.
 - 6. Based upon the foregoing evidence, the Board makes the following findings:

A. The applicant has demonstrated that the requested variance relief may be granted without substantial detriment to the public good and without substantially impairing the intent and purpose of the zone plan or Zoning Ordinances of the Township of Little Egg Harbor.

NOW, THEREFORE, BE IT RESOLVED, by the said Board that on this 10th day of March, 2021, based upon the findings herein above stated, the application is hereby granted subject to the following conditions, together with all stipulations of the applicant:

1. The applicant shall strictly adhere to the representations, plans and exhibits submitted with regard to the proposed development of the subject property and should further comply in all respects with the technical review letter as prepared by the Little Egg Harbor

Township Zoning Board of Adjustment Engineer dated December 30, 2020, a copy of which is annexed hereto and made a part hereof.

- 2. The Applicant is granted the following variances:
- A. Minimum Lot Depth to Bulkhead §15-4.14F(1)(b): where 87 FT is required and 80.44 FT is existing .
 - 3. The Applicant shall comply with RSIS standards with respect to parking.
- 4. Applicant testified that the grade of the property is not being changed in any way that might cause additional run-off from the property onto neighboring properties. Run off shall flow into a French drain.
 - 5. Applicant shall provide a CAFRA permit should same be required.
 - 6. Applicant testified that there shall be no living space under the house.
 - 7. Applicant testified that the driveway would be either pavers or cement.
 - 8. Applicant shall comply with the Ordinance regarding street trees.
- 9. The applicant shall further reimburse the Little Egg Harbor Township Zoning Board of Adjustment for all professional fees expended with regard to this application within thirty (30) days from the date of memorialization of this Resolution or any approvals granted herein shall automatically become null and void.
- 10. The applicant shall further secure any and all other necessary applications, permits or approvals and post any surety bonds that may be required by any other governmental agency.

11. The applicant shall resubmit this entire proposal should there be any substantial deviation from this Resolution or the submitted plans, documents, or oral representations made by this applicant.
