NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey to hereby authorize a Veteran's Property Tax Exemption discharge of debt for the 2021 taxes and if applicable authorize a refund in accordance with Rider 21-01, Rider 21-02, Rider 21-03 attached hereto and made a part hereof and that a certified copy of this resolution shall be forwarded to the Tax Collector.
