WHEREAS, the governing body wishes to authorize execution of the Memorandum of Agreement and subsequent collective bargaining agreement with the AFSCME LOCAL 3304D (White Collar).

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1. That the governing body does hereby authorize the execution of the Memorandum of Agreement with the AFSCME LOCAL 3304D (White Collar) for a period of time retroactive from January 1, 2020, to December 31, 2023 in a form acceptable to the Township Labor Counsel.
- 2. That the governing body further authorizes the execution of the collective bargaining agreement which will incorporate the terms of the Memorandum of Agreement between the Township of Little Egg Harbor and the AFSCME LOCAL 3304D (White

- 5. That a certified copy of this resolution shall be forwarded to the AFSCME LOCAL 3304D (White Collar) and the Chief Financial Officer/Township Administrator.
