

**RESOLUTION NO. 2021 – 111**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE LITTLE EGG HARBOR SCHOOL DISTRICT**

**WHEREAS**, the Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 *et seq.*, authorizes the Township of Little Egg Harbor to enter into a contract for the provision of certain governmental services with the Little Egg Harbor School District (hereinafter “School District ”); and

**WHEREAS**, N.J.S.A. 40A:65-5 requires that such a contract be authorized by resolution; and

**WHEREAS**, the School District is in need of supplies for winter snow and ice events as well as repair and maintenance services for School District equipment and vehicles; and

**WHEREAS**, the Department of Public Works of the Township of Little Egg Harbor has the materials for snow and ice events as well as the capability to repair and maintain equipment and vehicles; and

**WHEREAS**, it is the desire of the governing body to authorize the execution of a Shared Services Agreement with the School District for the enumerated services of the Little Egg Harbor Township Department of Public Works.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of a Shared Services Agreement with the School District, for Township Department of Public Works

services, in accordance with the terms of said agreement attached hereto and made a part hereof as Schedule A. The form of said agreement is subject to the approval of the Township Attorney.

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to the Shared Services Agreement, and any other documents necessary to effectuate the terms of this resolution.

3. That the term of the agreement shall be for three (3) years.

4. That a copy of the agreement referenced herein shall be kept on file and made available for public inspection at the Township Clerk's Office during normal business hours.

5. That a certified copy of this resolution, together with a copy of the agreement, shall be forwarded to the Superintendent of the Department of Public Works, the Township Administrator, the School District, and the Department of Community Affairs.
