**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING RESOLUTION 2021-138 SO AS TO AMEND APPLICATION FOR A GRANT FROM THE STATE OF NEW JERSEY, SAFE AND SECURE COMMUNITIES GRANT PROGRAM**
