**RESOLUTION OF THE TOWNSHIP OF LITTLE
EGG HARBOR, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AWARDING A CONTRACT FOR
FY 2021 NJDOT MUNICIPAL AID ROAD
PROGRAM – IMPROVEMENTS TO SEABREEZE
DRIVE AND TRADEWINDS DRIVE TO EARLE
ASPHALT COMPANY (BASE BID AND
ALTERNATE BID ‘A’)**

WHEREAS, the Township of Little Egg Harbor duly advertised for the receipt of bids for FY 2021 NJDOT Municipal Aid Road Program – Improvements to Seabreeze Drive and Tradewinds Drive, with Alternate Bid ‘A’ and ‘B’; and

WHEREAS, in response to the invitation to bidders, two (2) bids were received on July 28, 2021; and

WHEREAS, the bid has been reviewed by the Township Engineer and the Township Attorney, and it has been determined that Earle Asphalt Company, submitted the lowest responsible bid in accordance with the bid specifications, said base bid being \$553,413.13, and Alternate Bid A for curbing/drainage improvements at the intersection of Country Club Boulevard and Overlook Drive being \$23,500, totaling \$576,913.13; and

WHEREAS, it is the desire of the governing body to award a contract for FY 2021 NJDOT Municipal Aid Road Program – Improvements to Seabreeze Drive and Tradewinds Drive to Earle Asphalt Company in the amount of \$576,913.13, representing base bid of \$553,413.13 and Alternate Bid ‘A’ in the amount of \$23,500.00.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1.** That the governing body does hereby award a contract for FY 2021 NJDOT Municipal Aid Road Program – Improvements to Seabreeze Drive and Tradewinds

Drive to Earle Asphalt Company in amount of \$576,913.13, representing base bid of \$553,413.13 and Alternate Bid 'A' in the amount of \$23,500.00, said award subject to the review and approval of the New Jersey Department of Transportation.
