## <u>RESOLUTION NO. 2021 – 174</u>

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES ON PROPERTY QUALIFYING FOR VETERANS' PROPERTY TAX EXEMPTION (WILLIAM J. MATHIS, BLOCK 325.61, LOT 36)

**WHEREAS**, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 325.61, Lot 36, owned by William J. Mathis, qualified for a Veterans' Property Tax Exemption in the year 2020; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$4,278.69; and

WHEREAS, it is the desire of the governing body to authorize the Tax Collector to cancel those taxes for year 2021 on said property qualified under Veterans' Property Tax Exemption.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$4,278.69 for the year 2021 for Block 325.61, Lot 36, owned by William J. Mathis, as said property has been determined to qualify for a Veterans' Property Tax Exemption under N.J.S.A. 54:4-3.30.
