- 2. That the Mayor is authorized and the Township Clerk to attest to the Subrecipient Agreement with the County of Ocean, attached hereto as "Schedule A" for the HUD CDGB grant award of \$35,000, in accordance with the terms of this Resolution.
- 3. That a certified copy of this Resolution shall be forwarded to the interim Township Administrator and the County of Ocean.
