**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY,
AUTHORIZING ASSIGNMENT OF TAX SALE
CERTIFICATE #10-00004**

WHEREAS, N.J.S.A. 54:5-113, authorizes assignment by a municipality of Tax Sale Certificates for the full amount of the certificate(s), including all subsequent municipal taxes and other municipal charges; and

WHEREAS, JPC Group, Inc., has presented an offer to purchase, by assignment, Certificate of Sale #10-00004 which was issued to the Township of Little Egg Harbor at a tax sale held December 13, 2010, on Block 66, Lot 1, known as Lane off Thomas Ave., Little Egg Harbor, NJ and assessed to Renegade Real Estate Holdings, LLC, in the amount of \$ 53,632.15, being the full amount of the certificate, including all subsequent municipal taxes and other municipal charges.




ASSIGNMENT OF TAX SALE CERTIFICATE
