

**RESOLUTION NO. 2021-60**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A COLLECTIVE BARGAINING AGREEMENT AND THE RATIFICATION OF A MEMORANDUM OF AGREEMENT WITH AMERICAN FEDERATION OF STATE, COUNTY & MUNICIPAL EMPLOYEES, NEW JERSEY, (AFSCME) LOCAL 3304E (BLUE COLLAR)**

**WHEREAS**, the negotiation committees of the Township of Little Harbor and the AFSCME LOCAL 3304E (Blue Collar) met and negotiated terms and conditions of employment for the Blue Collar employees of Little Egg Harbor Township; and

**WHEREAS**, the parties have come to an agreement with regard to the terms and conditions of the collective bargaining agreement; and

**WHEREAS**, the parties have entered into a Memorandum of Agreement with regard to said terms and conditions of employment for the period of time between January 1, 2019 and December 31, 2021; and

**WHEREAS**, the governing body wishes to ratify the Memorandum of Agreement and authorize the execution of a collective bargaining agreement with the AFSCME LOCAL 3304E (Blue Collar).

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of a collective bargaining agreement with the AFSCME LOCAL 3304E (Blue Collar) for a period of time retroactive from January 1, 2019, to December 31, 2021.

3. That the governing body further ratifies the Memorandum of Agreement between the negotiating committee of the Township of Little Egg Harbor and the negotiating

committee of the AFSCME LOCAL 3304E (Blue Collar) with regard to the terms and conditions of employment.

4. That the Mayor is hereby authorized to execute and the Township Clerk to attest to the Memorandum of Agreement with the AFSCME LOCAL 3304E (Blue Collar) and the Township, and the collective bargaining agreement between the Township and the AFSCME LOCAL 3304E (Blue Collar).

5. That this resolution shall take effect immediately.

6. That a certified copy of this resolution shall be forwarded to the AFSCME LOCAL 3304E (Blue Collar), the Chief Financial Officer and the Township Administrator.
