**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR 2020 DRAINAGE IMPROVEMENT PROJECT TO MNC CONCRETE LLC**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for the receipt of bids for the 2020 Drainage Improvement Program; and

**WHEREAS**, in response to the invitation to bidders, nine (9) bids were received on February 4, 2021 and

**WHEREAS**, the bids have been reviewed by the Township Attorney and the Township Engineer and it has been determined that MNC Concrete LLC submitted the lowest responsible and responsive bid in accordance with the bid specifications, said bid being \$219,676.40 Base Bid, Alternate Bid A for \$33,572.64, Alternate Bid B for \$17,443.64, Alternate Bid C for \$13,782.00 and Alternate Bid D for \$3,650.00 for a total of \$288,124.68; and

**WHEREAS**, it is the desire of the governing body to award a contract for the 2020 Drainage Improvement Project to MNC Concrete LLC.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1.** That the governing body does hereby award a contract to MNC Concrete LLC, to the lowest responsible and responsive bidder, for the 2020 Drainage Improvement Program at \$219,676.40 Base Bid, Alternate Bid A for \$33,572.64, Alternate Bid B for \$17,443.64, Alternate Bid C for \$13,782.00 and Alternate Bid D for \$3,650.00 for a total of \$288,124.68.
