## **RESOLUTION NO. 2021 – 90**

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE CURBSIDE COLLECTION OF SOLID WASTE FOR HARBOURTOWN VILLAS ASSOCIATION IN ACCORDANCE WITH N..J.S.A. 40:67-23.2.

WHEREAS, N.J.S.A. 40:67-23.2 provides that the governing body may make an ordinance in which the municipality may provide for curbside collection of solid waste along streets not taken over by the municipality or dedicated and accepted as public highways; and

WHEREAS, accordingly, Chapter 277 of the Township Code provides that the Township shall have the option to provide these services in the same fashion as the municipality provides these services on public roads and streets; and

WHEREAS, nothing in N.J.S.A. 40:67-23.2 requires a municipality to operate any municipally owned or leased vehicles or other equipment or to provide any of the services enumerated N.J.S.A. 40:67-23.1(a) upon, along or in relation to any road or street in a qualified private community which either is not accepted for dedication to public use or does not meet all municipal standards and specifications for such dedication, except for width; and

WHEREAS, Harbourtown Villas Association, a qualified private community, is adjacent to a private roadway owned by another qualified private community, and desires curbside collection of solid waste and recyclable materials; and

WHEREAS, the Township Committee wishes to authorize curbside collection of solid waste and recyclable materials at Harbourtown Villas Association, in accordance with N.J.S.A. 40:67-23.1 and Chapter 277 of the Township Code.

- 2. That the governing body may limit these curbside collection services of solid waste and recyclables to specified operating hours in order to preserve the peace and quiet in neighborhoods during the hours when most residents are asleep.
- 3. That the governing body provides these services subject to the provisions of N.J.S.A. 40:67-23.1. and the Municipal Services Act.
- 4. That a certified copy of this resolution shall be forwarded to the Township Administrator, Chief Financial Officer and Harbourtown Villas Association.
