

RESOLUTION NO. 2021 – 99

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY SUPPORTING
THE APPLICATION TO THE NEW JERSEY DEPARTMENT OF
TRANSPORTATION (“NJDOT”) BY THE COUNTY OF OCEAN
FOR STREET INTERSECTION IMPROVEMENT AND A FOUR
(4) TON WEIGHT LIMIT ON CENTER STREET FROM OAK
LANE TO ROUTE 9**

WHEREAS, currently, vehicular traffic uses Center Street from Route 9 to Oak Lane as a cut-through, causing issues in the surrounding neighborhoods; and

WHEREAS, Center Street is under the jurisdiction of the County of Ocean; and

WHEREAS, the Township of Little Egg Harbor has requested that the County of Ocean address the problems at Center Street by restricting certain vehicles and modifying the intersection; and

WHEREAS, the County of Ocean, in response to the requests from the Township, intends to establish a 4 Ton Weight Limit restriction, and make modifications to the intersection of Center Street and Route 9, in accordance with the concept attached as Schedule A hereto, with the intent to provide an additional barrier to using Center Street as a cut through by requiring vehicles to make a left turn from Route 9 southbound onto Maple Avenue and a right onto Center-Street; and

WHEREAS, the Township of Little Egg Harbor supports the County of Ocean’s application to the NJDOT for street intersection improvement and 4 Ton Weight Limit on Center Street from Oak Lane to Route 9.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby strongly support the application to the NJDOT by the County of Ocean for street intersection improvement and 4 Ton

Weight Limit on Center Street from Route 9 to Oak Lane, in accordance with the concept attached as Schedule A hereto.

2. That a certified copy of this resolution be forwarded to the County of Ocean, the Ocean County Engineer, and the Borough of Tuckerton.
