RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE APPOINTMENT OF LITTLE EGG HARBOR TOWNSHIP COMMITTEE MEMBER TO FILL VACANCY PURSUANT TO N.J.S.A. 40A:16-1 et seq.

WHEREAS, Barbara Jo "Bobbi" Crea was duly elected to the position of Committeeperson for the Township of Little Egg Harbor to serve a three (3) year term which would have expired December 31, 2022; and

WHEREAS, Ms. Crea resigned on January 4, 2021 from her position as

Committeeperson for the Township of Little Egg Harbor in accordance with N.J.S.A. 40A:16
3(f); and

WHEREAS, in a municipality holding general election, whenever a vacancy occurs as provided in [N.J.S.A. 40A:16-3] in the membership of the governing body of a municipality holding general elections, and the vacancy occurs any time subsequent to September 1 of the next-to-the-last year and up to the expiration of the term of the officer whose office has become vacant, the office may be filled for its unexpired term by appointment by the governing body as provided within the Municipal Vacancy Law; and

WHEREAS, as Ms. Crea was elected as a nominee of the Republican Party, the appointment to fill the vacancy occurs pursuant to N.J.S.A. 40A:16-11; and

WHEREAS, the Little Egg Harbor Republican County Committee considered four potential candidates and Kenneth Laney, Jr. was the sole candidate to satisfy the qualifications to be a nominee; and
