WHEREAS, the fire district must seek annual approval of elected commissioner compensation from the municipal governing body regardless of whether the Board is modifying the amount of compensation pursuant to <u>Oughton v. Board of Fire Comrs.</u>, 178 N.J. Super. 565, 570-571 (App. Div. 1981); and

WHEREAS, in order for Fire District No. 3 to authorize its elected commissioners to receive compensation, the Board of Fire Commissioners adopted a Resolution establishing the level of compensation, attached hereto and made a part hereof; and

WHEREAS, the governing body hereby reviewed and desires to approve of the schedule of compensation for the Board of Fire Commissioners, District No. 3 in the Township of Little Egg Harbor.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby approve of the proposed annual compensation for the Fire Commissioners for District No. 3 as set forth in the Board of Fire Commissioners District No. 3 Resolution, attached hereto as Schedule A.
