# **PUBLIC COMMENT**

Mr. Art Mooney of Windstar Drive had a list of various items from prior meetings that he was looking for a status on including: the sale of Sea Oaks, their liquor license and the preapproved condominiums, rumor of Shooters closing, an email he submitted regarding Marijuana and the Township Police Officers, information on the Master Plan Committee members, American Rescue Fund ideas, bus shelters upkeep and maintenance, budget highlights and the condition of Leitz Blvd. roadway.

Business Administrator/CFO Rodney Haines stated Sea Oaks has submitted an application for renewal but the license transfer has not been submitted yet.

Township Attorney Melanie Appleby stated once the transfer application is submitted, the Committee will approve a Resolution for the transfer of the license to the new owners. She stated she believes all permits have expired and the new owners would have to get permission from the Planning Board for approvals on the condominiums.

Township Engineer Jason Worth provided an overview of the condominiums previous approval and what will be required since the approval extensions are now expired.

Mayor Kehm stated he has not heard the rumor of Shooters closing.

Mayor Kehm stated he, Deputy Mayor Scibetta and Chief Hawkins discussed regulations on Township Police Officers and Marijuana and what they are looking to implement.

Business Administrator/CFO Rodney Haines stated the Master Plan is set by the Committee and that the plan and changes are done by the Committee and through the Township Planner. He stated there will be no Committee created for the Master Plan Reexamination.

Mayor Kehm stated the Township has a list of ideas they are deciding on for the American Rescue Plan funds including two Resolutions that were approved at the previous meeting for Drone Inspections and Township bulkheads.

Business Administrator/CFO Rodney Haines stated the bus shelters are on the list to be discussed for the American Rescue Plan and the Township will maintain the bus shelters.

Business Administrator/CFO Rodney Haines gave a brief overall on the highlights of the 2022 Municipal Budget and he stated the public hearing and adoption will be at the June meeting.

Township Engineer Jason Worth stated he spoke with the Director of Public Works and the pot holes will be fixed on Leitz Blvd.

Mr. Art Mooney ended by thanking Katie Baker, Mr. Ken Maxwell and Committeeman Daniel Maxwell for the success of the Senior Expo.

Beverly Weed-Schertzer requested a status on the Mystic Island Phase 2 dredging project, provided information to Committeeman Gormley on Brick dredging project and questioned the Township bulkhead repairs.

Business Administrator/CFO Rodney Haines stated a letter regarding the status of Mystic Island Phase 2 dredging was put on the Township website as well as on Facebook. He further stated at this time the Phase 2 dredging will be on hold.

Mayor Kehm stated no letter will be sent out to the residents and the follow-up from the poll is posted for residents on the website, Facebook and in the newspaper and at this time the dredging will not be going any further.

Committeeman Ray Gormley stated Tuckerton Borough is currently going out to bid for dredging and once those bids come back, the Township will have an idea of what the current pricing is and go from there.

Township Engineer Jason Worth provided the process and status of the bulkhead repairs.

The resident of 226 Center Street (No name given) stated she has concern on the safety of children due to 18 wheeler trucks that are barreling down Center Street.

Township Engineer Jason Worth stated Center Street is a County roadway and at this point the Township's hands are tied and it is up to the County to complete what they have proposed to the state for the roadway. He also stated he believes the County is waiting on Department of Transportation to finish the process.

Amanda Mallard of Center Street expressed how dangerous Center Street is around the curve in the roadway. She asked if anyone has thought of making the entire road a one way.

Township Engineer Jason Worth stated he believes the County did look into all options for the roadway. He further stated that he will reach out to them and recommend it.

Mayor Kehm requested that the Township Engineer reach out to the County regarding cleaning up the area where the curve is as well.

Committeeman Ray Gormley stated the problem is the roads are old and when the roads were created, the County did not take into effect the amount of traffic that Little Egg Township now has.

Molly Denesco of South Miami Drive asked what the duties are of the elected officials and their resumes.

Mayor Kehm stated Ocean County Clerk's Office will have information on their website.

Rose Mulholland from Spruce Drive spoke about the drainage issue and sink holes around her home from the pipes.

Business Administrator/CFO Rodney Haines stated he is trying to get the drainage fixed with an upcoming Capital Ordinance. He stated an estimate was provided by the Township Engineer to replace the pipes and the information was provided to the Township Committee to discuss regarding funding and will hopefully be on an upcoming agenda.

Cynthia Veramo at Newport Way has concerns with the speeding on Great Bay Blvd and the Diamondback Terrapins.

Mayor Kehm requested that the Business Administrator/CFO Rodney Haines reach out to Chief Hawkins and have him send a few Class II Officers to patrol the area.

Mr. Art Mooney of Windstar Drive suggested a sign of "no through traffic" on both ends of Center Street.

Dr. John Edmunds of Spruce Drive provided an update on the Center Street project and he stated after hearing everyone from the meeting clearly more police officers are needed throughout the Township to control the speeding issue.

Amanda Mallard of Center Street questioned the bid process for Center Street and what protection does the home owners have for their property foundations.

Township Engineer Jason Worth explained the bid process and he will look into the Center Street County bid. He also stated the County will have to take precautions during the reconstruction process for the foundation of the homes in that area during the reconstruction project.

Deputy Mayor Scibetta asked if the County can attend the next meeting and go over the reconstruction of Center Street for residents so they can ask questions regarding the project.

Township Engineer Jason Worth stated he has not received any information on the bid, but he will look into it.

#### **TOWNSHIP ENGINEER COMMENTS**

Township Engineer Jason Worth stated Earle Asphalt is continuing with the paving on the Mullica's Delaware's and Mohawk's off Twin Lakes Blvd and will continue the restoration next week on the new road. He further stated the sodding of the Soccer and Football fields are underway and fields 2, 3 and 4 will be wrapping up in the next few weeks, weather permitting. He continued stating the bulkhead work that was previously authorized is underway and within the next few weeks the permit will be submitted. He stated the FY2023 NJDOT Municipal Aid applications have been announced and the deadline for those applications are July 1. He stated he spoke with the Township Administrator and the Director of Public Works and they have some good recomendations. Lastly, he stated the recertification of Sustainable Jersey and the first step for the recertification will be submitted next week. He ended with praising the Environmental Commission for all the projects they have done, as well as, the assistance they provide for the recertification.

Mayor Kehm questioned the Infrastructure application that was submitted and if he heard anything.

Township Engineer Jason Worth stated he has not heard anything on the Infrastructure application but there are a lot of grants that the state will soon be announcing that the Township will be applying for.

Deputy Mayor Scibetta questioned if the Township has heard anything from Atlantic City Electric or the BPU. He stated something legal needs to be sent out to move things forward.

Township Engineer Jason Worth stated he spoke with the BPU and they have not heard anything from Atlantic City Electric but he will be contacting them to get a status and hopefully set up a meeting regarding the capacity limits for solar projects. He stated he will provide the information to the Township Attorney to draft a legal document to be sent out.

### **TOWNSHIP COMMITTEE COMMENTS**

Committeeman Daniel Maxwell thanked the Pilgrim Academy 7<sup>th</sup> grade class for their yearly service project of cleaning, mulching and planting flowers at the Township and Little Treasures Park and pics are on the Township Facebook page of the event. He stated the organizer of the event thanked the Public Works Department for helping put the project together. Committeeman Maxwell provided an

update on the Senior Expo and the Senior Advisory Board and thanked Ken Miller, Katie Baker and the Senior Advisory Board for all their hard work in putting the event together. He stated the next Senior Advisory Board meeting will be Tuesday, May 24, 2022 at 10am at the Community Center.

Committeeman Ray Gormley requested that Ken Miller stand up and he gave credit to him and Katie Baker for all the hard work they put into the event.

Deputy Mayor Blaise Scibetta reported that he attended, on behalf of the Mayor, a PAL meeting, first since 2019, which included Chief Hawkins, the Eagleswood Mayor and representatives of Tuckerton Borough. He stated they are reviewing their by-laws and more meetings are to come. He also stated himself and Committeeman Maxwell attended a meeting with senior residents regarding information on Trash pick-up. He thanked Katie Baker for creating a one page document with all the trash information for new residents. He also stated the information will be posted on the Township Information Board, website and Facebook page and copies available at the Township building.

Mayor John Kehm congratulated Committeeman Maxwell, Katie Baker and Ken Miller on a successful senior expo event. He also stated a lot of volunteers were lost from EMS Squad 85 and they are looking for volunteers and anyone who is interested in volunteering, can reach out to them for information. He ended with wishing everyone a safe Memorial Day.
