Mr. James MacKenzie, Great Bay Boulevard: He questioned if the most recent reduction in the estimated costs are because the State will be dredging further in and the depth of the dredging has been modified.

Township Engineer Jason Worth explained the State DOT Office of Maritime Resources will be dredging a portion of what was in the original proposal and an analysis was made on if we went from 4 ½ foot depth to 3 ½ foot depth how does that reduce the amount of dredge materials and that is what was put out in the most recent question.

Mr. James Mackenzie, Great Bay Boulevard: What is the average low tide depth of the Thoroughfare.

Township Engineer Jason Worth stated there is approximately one to two feet at low tide.

Mr. James MacKenzie, Great Bay Boulevard: Expressed his opinion that he is not in favor of the dredging since most boats go out for maybe 3-4 months a year.

Township Engineer Jason Worth explained a survey was done and dredging will be done in all areas that have 3 ½ feet or less of water at low tide. Causing an equal effect throughout the entire area.

Mr. James MacKenzie, Great Bay Boulevard: Commented he did not like the wording of the vote/announcement property owners received.

Township Attorney Melanie Appleby explained the tally was done as an assessment to get the feel of the community and is not a legal requirement.

Mr. James MacKenzie, Great Bay Boulevard: Asked for the final vote.

Township Engineer Jason Worth: Explained an analysis was done from the first vote to the second vote. The second vote received 96 respondents with more in favor than not in favor.

Mr. James MacKenzie, Great Bay Boulevard: Asked if the Atlantis dredging and Mystic Island West dredging projects could be combined.

Township Engineer Jason Worth: Explained the projects will be bid at the same time.

Ms. Andrea Dinkowitz, Atlantis Boulevard: Expressed her opinion on the unfairness of the dredging vote, she complained her taxes are going up and she'll have to pay the special assessment plus the interest rate on the loan.

Mr. Dave Fisher, Atlantis Boulevard: Objects to the dredging project and the process used for voting.

Ms. Marilyn Stein, Sea Isle Drive: Mentioned her land developer/builder owns about six lots in her development and asked if he will be responsible for paying on those properties.

Committeeman Ray Gormley explained each lot pays and equal amount.

Mr. Ed Andrew, Osborn Island: Gave a positive commentary on the Osborn Island dredging project.

Ms. Debbie Fisher, Atlantis Boulevard: Believes it is unfair that many people use the water however only the ones that live on the water are paying for the dredging.

Mr. James MacKenzie, Great Bay Boulevard: Big Thoroughfare is a large part of the dredging project and he asked if it is a private or public waterway; he does not feel the residents should have to pay for it.

Committeeman Ray Gormley believes it is owned by the DEP and the channel that leads to the lagoons was man made and is not a mapped-navigable waterway, therefore the State will not pay for it.

Ms. Andrea Dinkowitz, Atlantis Boulevard: Expressed her concerns with traffic and speeding on her street and throughout the township.

Ms. Candy, Center Street: Spoke about issues on Center Street including trucks over 4 tons and drivers not following the speed limit.

Township Engineer Jason Worth stated the County is taking over the Tuckerton portion of the road to limit movements from Route 9 down Center Street towards Oak Lane; the County is in need of State approval to commence work.

Mr. Dave Fisher, Atlantis Boulevard: Stated there is still flooding issues after the pipe work on Pinehurst Drive.

Township Engineer Jason Worth explained sediment bags were placed inside the basins to prevent dirt from getting inside during construction. Public Works removed the bags the other day.

Mr. Art Mooney, Windstar Drive: Discussed traffic issues on Radio Road, his concerns regarding the legalization of Marijuana, and the four million dollar FEMA disaster money.

CFO Rodney Haines mentioned the 4 million dollars is the community disaster loan we are working on getting forgiven. With regard to the 2.1 million dollars of the American Recovery Act run by the State, they are working on the guidelines as to how the money can be used which he explained.

Ms. Gail Kelly, Country Club Boulevard: Spoke about property maintenance issues on County Club Boulevard.

Mayor Kehm stated he will have Code Enforcement look into the matter.

Mr. Paul Lafferty, South Commodore Drive: Asked if Big Creek will be dredged.

Township Engineer Jason Worth explained certain portions of Big Creek will be dredged but not all of it.

Mr. Paul Lafferty, South Commodore Drive: Asked for relief from boats speeding in the lagoons.

Ms. Elaine, Center Street: Commented there are no safe areas to walk on Center Street.

Ms. Rose Maholland, Spruce Drive: Spoke about drivers speeding down the road as well as large trucks shaking the houses when they go by.

Mayor Kehm suggested she reach out to the State Police since they handle the DOT.

Mr. Andy Cameolla, North Forecastle Drive: Asked if the township hired a drone to view the lagoon areas.

Mayor Kehm stated yes the town did.

Ms. Amanda Mawry, Center Street: Believes the large trucks are damaging the pipes in her house when they drive by. She also expressed her concerns for the children riding their bikes on Center Street.

Township Engineer Jason Worth stated he spoke to the County this week about many of these issues which he discussed.

Tom Zewerski, Center Street: Does not believe the police are monitoring Center Street like they should.

Mr. Frank Minchel, South Longboat Drive: Spoke about boats and jet ski's speeding between the area of Twin Lakes Boulevard and the bridge and asked for more state police/marine police presence.

Mr. Dave Fuller, Louisiana Drive: Read a prepared statement regarding cracks in the roads and asked if the raw materials needed for public works to repair them using the pothole repair patch trailer have been purchased.

Township Administrator Rodney Haines explained he spoke with the Superintendent of Public Works and the trailer doesn't deal with the liquid sealer for that type of work; however we are purchasing a piece of equipment for sealing cracks in the near future.

Mr. John Edmunds, Spruce Drive: Believes our Police Department is stretched thin for the amount of residents in this town.

Mayor Kehm stated we have approximately forty four police officers which are separated between the north and south end of town which he explained.
