**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING
THE RENEWAL OF AN PLENARY RETAIL ALCOHOLIC
BEVERAGE CONSUMPTION LICENSE (INACTIVE) TO SEA OAKS
COUNTRY CLUB, LLC IN ACCORDANCE WITH A STATE,
DIVISION OF ALCOHOLIC BEVERAGE CONTROL SPECIAL
RULING FOR THE 2022-2023 LICENSE TERM**

WHEREAS, Sea Oaks Country Club, LLC holds License No. 1516-33-009-005 which was last renewed by Resolution 2021-134, set to expire June 30, 2022, and is now currently in an Inactive status pursuant to N.J.S.A. 33:1-12.39, which states that no Class C license shall be renewed if the same has not been actively used in connection with the operation of a licensed premises within a period of two years prior to the commencement date of the license period for which the renewal application is filed unless the director, for good cause and after a hearing, authorizes a further application for one or more renewals within a stated period of years; and

WHEREAS, Sea Oaks Country Club, LLC filed a verified petition requesting authorization for Little Egg Harbor Township to consider a renewal application for said license for the 2022-2023 license term pursuant to the provisions of N.J.S.A. 33:1-12.39; and

WHEREAS, the State of New Jersey, Department of Law and Public Safety, Division of Alcoholic Beverage Control considered the application and found that the licensee had established good cause in accordance with the statutory requirements to warrant an application for renewal of the license for the license term; and

WHEREAS, the New Jersey Division of Taxation has issued Tax Clearance Certificates to the Licensee, copies of which have been provided to the Municipal Clerk in order to satisfy the requirements for the renewal of consumption/distribution licenses; and
