

RESOLUTION NO. 2022 - 151

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE PREPARATION OF SPECIFICATIONS FOR SKATE PARK IMPROVEMENTS AT THE COMMUNITY CENTER

WHEREAS, the Township is in need of Skate Park Improvements at the Community Center (site work only); and

WHEREAS, the Township Engineer's estimate of anticipated cost for construction of site work for Skate Park Improvements at the Community Center is \$182,868.00, in accordance with the attached Schedule A (Engineer's Estimate of Costs prepared by T&M Associates); and

WHEREAS, since the estimated costs exceed \$17,500.00, the project must be publicly bid in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*; and

WHEREAS, it is the desire of the governing body to advertise for and receive bids for construction of site work for Skate Park Improvements at the Community Center, and further to authorize the Township Engineer and other appropriate Township personnel to prepare the bid specifications for the receipt of bids for construction of site work for Skate Park Improvements at the Community Center.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the preparation of specifications, and the subsequent receipt of bids for construction of site work for Skate Park Improvements at the Community Center to be performed by the Township Engineer and other

appropriate Township personnel. The Township shall determine the time, date and place for the receipt of said bids.


2. That the Township Engineer and appropriate personnel are hereby authorized to prepare the bid specifications for the construction of site work for Skate Park Improvements at the Community Center.
