**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1. That the governing body does hereby authorize the execution of a memorandum of agreement with AFSCME NJ Council #63 in a form substantially similar to the agreement attached hereto as schedule A and approved by the Township Labor Attorney.
- 2. That a certified copy of this resolution, together with a copy of the agreement between the parties, shall be forwarded to the AFSCME NJ Council #63, Township Chief Financial Officer, Township Labor Counsel and Ms. Barbara Jeffrey.

## **MEMORANDUM OF AGREEMENT**

This Memorandum of Agreement ("Agreement") is made this \_\_\_\_\_ day of 2022, by and between the AFSCME NJ Council #63, Local 3304D, White Collar (Union) and Township of Little Egg Harbor

WHEREAS, the Township and the AFSCME NJ Council #63, Local 3304D, White Collar (Union), were parties to a collective negotiations agreement with a term of January 1, 2020 through December 31, 2023; and

WHEREAS, unit member and employee of the Township, Barbara Jeffrey has recently been appointed to the title Account Clerk/Clerk 2; and

WHEREAS, the title does not appear in Article I Recognition Clause of the governing agreement between the parties; and

WHEREAS the parties desire to include the new title in the contract.

**NOW THEREFORE**, the Parties hereby agree to the following:

- 1. Except as herein modified, the terms and conditions set forth in the January 1, 2020 through December 31, 2023 Collective Negotiations Agreement between the Township and the Union shall remain in full force in effect
- 2. Article I, Recognition, Section B of the collective negotiations agreement between the parties with a term of January 1, 2020 through December 31, 2023 is hereby amended to include the title of Account Clerk/Clerk 2.
- 3. Article I, Recognition, Section B of the collective negotiations agreement between the parties with a term of January 1, 2020 through December 31, 2023 is hereby amended to delete the title of Account Clerk/Cashier 2.
- 3. The parties agree that this agreement may not be modified, altered, changed, except upon express written consent of the Parties.
- 4. The Parties agree that if any portion of this Agreement is deemed unenforceable, the remainder of the Agreement shall be fully enforceable.
- 5. The Parties acknowledge that they have entered into this Agreement voluntarily and hereby sign it without duress or coercion.
- 6. The Parties acknowledge that the Union entered into this agreement after union ratification.
- 7. This Agreement shall be governed by the laws of the State of New Jersey.

The Parties hereby acknowledge their agreement to the terms and conditions set forth above by signing below.
