WHEREAS, it is the desire of the governing body to award a contract for the 61 Glock Handguns and 22 Streamlight Flashlights to Witmer Public Safety Group, Inc. pursuant to State Contracts 17-FLEET-00767 and 17-FLEET-00764.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:
