NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body hereby authorizes the renewal of the membership in the Ocean County Municipal Joint Insurance Fund for a period of three (3) years, beginning January 1, 2023, and ending December 31, 2025.
