RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING EMERGENCY CONTRACT PURSUANT TO N.J.S.A. 40A:11-6 FOR WORK TO ENTRY DOORS AT MUNICIPAL COMPLEX AT 665 RADIO ROAD

WHEREAS, the Township of Little Egg Harbor was notified on August 2, 2022 of a safety situation, in that the doors to the Little Egg Harbor Township Municipal Complex are not functioning properly and access to the Municipal Building is infringed for disabled persons attempting to enter or exit the Municipal Building, creating an immediate safety issue; and

WHEREAS, additionally, the malfunctioning doors create a safety issue as to securing the building; and

WHEREAS, the governing body has obtained a quote for repair of the entry doors at 665 Radio Road in Little Egg Harbor in the amount of \$32,800.00; and

WHEREAS, N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1 provide for the making, negotiation or award of a contract for services and goods without public bidding in an emergency situation; and

WHEREAS, the situation is an immediate emergency affecting the public health, safety and welfare requiring the immediate performance of said services; and

WHEREAS, the Township Administrator has determined that this is an emergency which requires immediate action by the Township to secure the Municipal Complex at 665 Radio Road and protect the health, safety and welfare of the public; and

WHEREAS, upon the furnishing of such work or labor, materials, supplies or services, in accordance with the terms of the contract or agreement, the contractor furnishing such work or labor, materials, supplies or services shall be entitled to be paid therefor and the contracting unit shall be obligated for said payment.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:
