

RESOLUTION NO. 2022-208

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING KASEY P. POWERS AS QUALIFIED PURCHASING AGENT FOR THE TOWNSHIP OF LITTLE EGG HARBOR AND ESTABLISHING A NEW BID THRESHOLD IN ACCORDANCE WITH N.J.S.A. 40:11-3(a)

WHEREAS, the Township may appoint a Qualified Purchasing Agent for the purposes streamlining purchasing operations, improving staff access to purchasing resources, ensuring compliance with applicable laws, raising the bid threshold pursuant to N.J.S.A. 40A:11-3(a), and a number of other purchasing related services; and

WHEREAS, Kasey P. Powers has successfully met the requirements to become a Qualified Purchasing Agent pursuant to N.J.S.A. 40A:11-9 et seq.; and

WHEREAS, the governing body has determined that it is in the best interest of the Township to appoint Kasey P. Powers as Township Qualified Purchasing Agent; and

WHEREAS, upon appointment of said Qualified Purchasing Agent, the governing body establishes a bid threshold in accordance with N.J.S.A. 40A:11-3(a), currently \$44,000, or as adjusted by the Governor pursuant to the aforesaid statute.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That Kasey P. Powers is hereby appointed as Qualified Purchasing Agent for the Township of Little Egg Harbor effective immediately, at compensation in accordance with the applicable Collective Bargaining Agreement and the Township Salary Ordinance.


