RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (ERICA NELSON, BLOCK 285.11, LOT 2.26)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 285.11, Lot 2.26, owned by Erica Nelson, qualified for a Veterans' Property Tax Exemption in the year 2022; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$2,151.52; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2022 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, the Tax Collector deems that the mortgage company, Corelogic, receive a refund on taxes already paid for the year 2022 in the amount of \$461.12.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$2,151.52 for the year 2022 for Block 285.11, Lot 2.26, owned by Erica Nelson, and authorize a refund to the mortgage company, Corelogic, in the amount of \$461.12.
- 2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Erica Nelson, Corelogic and the Chief Financial Officer.

TOTALLY DISABLED VETERAN ASSESSMENT CREDIT WORKSHEET

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that the property known as Block 285.11 Lot 2.26 owned by Nelson, Erica qualifies for a Veteran's Property Tax Exemption as of May 4, 2022.

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a one hundred percent permanent and total wartime service-connected disability evaluation from the Veterans Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2022 based upon a prorated assessment of \$120,100 multiplied by the F01 Tax Rate, taxes outstanding that would otherwise be exempt.
