

**RESOLUTION NO. 2022-219**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,  
COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING  
THE TAX COLLECTOR TO CANCEL TAXES ON PROPERTY  
QUALIFYING FOR VETERANS' PROPERTY TAX EXEMPTION  
(BERNARD R. STAUNCH, BLOCK 325.309, LOT 2)**

**WHEREAS**, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

**WHEREAS**, it has been determined by the Tax Assessor that property known as Block 325.309, Lot 2, owned by Bernard R. Staunch, qualified for a Veterans' Property Tax Exemption in the year 2022; and

**WHEREAS**, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

**WHEREAS**, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$2,313.48; and

**WHEREAS**, it is the desire of the governing body to authorize the Tax Collector to cancel those taxes for year 2022 on said property qualified under Veterans' Property Tax Exemption.


**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$2,313.48 for the year 2022 for Block 325.309, Lot 2, owned by Bernard R. Staunch, as said property has been determined to qualify for a Veterans' Property Tax Exemption under N.J.S.A. 54:4-3.30.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Bernard R. Staunch and the Chief Financial Officer.




