**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING
THE TAX COLLECTOR TO CANCEL TAXES ON PROPERTY
QUALIFYING FOR VETERANS' PROPERTY TAX EXEMPTION
(JOHN H. KUPER, BLOCK 285.11, LOT 10.16)**

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 285.11, Lot 10.16, owned by John H. Kuper, qualified for a Veterans' Property Tax Exemption in the year 2022; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$2,806.00; and

WHEREAS, it is the desire of the governing body to authorize the Tax Collector to cancel those taxes for year 2022 on said property qualified under Veterans' Property Tax Exemption.


NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$2,806.00 for the year 2022 for Block 285.11, Lot 10.16, owned by John H. Kuper, as said property has been determined to qualify for a Veterans' Property Tax Exemption under N.J.S.A. 54:4-3.30.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, John H. Kuper and the Chief Financial Officer.



WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2022 based upon a prorated assessment of \$202,500 multiplied by the F01 Tax Rate, taxes outstanding that would otherwise be exempt.


