

**RESOLUTION NO. 2022-225**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, REJECTING ALL BIDS RECEIVED FOR MYSTIC BEACH AND PARKERTOWN BEACH REPLENISHMENT AND STABILIZATION PROJECT AND AUTHORIZING THE RE-ADVERTISEMENT AND RECEIPT OF BIDS**

**WHEREAS**, the Township of Little Egg Harbor duly advertised for the receipt of bids for the Mystic Beach and Parkertown Beach Replenishment and Stabilization Project; and

**WHEREAS**, eight (8) bids were received on September 2, 2022, in response to the invitation to bidders; and

**WHEREAS**, it is the desire of the governing body to reject said bids in accordance with N.J.S.A. 40A:11-13.2(a) because lowest bid substantially exceeds the cost estimates for the project; and

**WHEREAS**, it is the desire of the governing body to advertise for and receive bids for Mystic Beach and Parkertown Beach Replenishment and Stabilization.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That in accordance with N.J.S.A. 40A:11-13.2 the governing body does hereby reject all bids received for the Mystic Beach and Parkertown Beach Replenishment and Stabilization Project because the lowest bid substantially exceeds the cost estimates for the project.

2. That the governing body does hereby authorize the receipt of new bids for the Mystic Beach and Parkertown Beach Replenishment and Stabilization Project. The Township Clerk shall determine the time, date and place for the receipt of said bids.
