- 1. That in accordance with N.J.S.A. 40A:11-13.2 the governing body does hereby reject all bids received for the Mystic Beach and Parkertown Beach Replenishment and Stabilization Project because the lowest bid substantially exceeds the cost estimates for the project.
- 2. That the governing body does hereby authorize the receipt of new bids for the Mystic Beach and Parkertown Beach Replenishment and Stabilization Project. The Township Clerk shall determine the time, date and place for the receipt of said bids.
