- 4. That the Township Clerk shall prepare a notice for advertisement for a newspaper publication circulating in the Township, announcing the auction and the lots and blocks of the real property that will be sold online, indicating the internet address for the sale that is being advertised, including the date and time of the auction, that the Township has set minimum price for each property listed, and reserves the right to reject all bids in the event that the highest bid is not accepted, successful bidders shall be required to close title within twenty (20) days from the date of the auction, time being of the essence.
- 5. That the Township Clerk shall advertise the notice in Paragraph 5 above in a newspaper circulating in the Township, by two insertions at least once a week during two consecutive weeks before the auction, the last publication to be not earlier than seven (7) days prior to such sale.
