RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (WILLIAM J. GLENN, BLOCK 124, LOT 9.22)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 124, Lot 9.22, owned by William J. Glenn, qualified for a Veterans' Property Tax Exemption in the year 2022; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$1,370.20; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2022 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, the Tax Collector deems that the title company, Foundation Title, receive a refund on taxes already paid for the year 2022 in the amount of \$1,120.20; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$1,370.20 for the year 2022 for Block 124, Lot 9.22, owned by William J. Glenn and authorize a refund to the title company, Foundation Title, in the amount of \$1,120.20.
- 2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, William J. Glenn, Foundation Title and the Chief Financial Officer.

## TOTALLY DISABLED VETERAN ASSESSMENT CREDIT WORKSHEET

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that the property known as Block 124 Lot 9.22 owned by Glenn, William J qualifies for a Veteran's Property Tax Exemption as of November 10, 2022.

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a one hundred percent permanent and total wartime service-connected disability evaluation from the Veterans Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2022 based upon a prorated assessment of \$344,300 applied by the F03 Tax Rate, taxes outstanding that would otherwise be exempt.
