## ORDINANCE 2023-02

AN ORDINANCE BY THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW LITTLE EGG HARBOR, AMENDING AND SUPPLEMENTING THE TOWNSHIP CODE SO AS TO AMEND CHAPTER 217, LICENSING

**NOW, THEREFORE, BE IT ORDAINED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Little Egg Harbor, as follows:

**SECTION 1.** That the governing body hereby amends Chapter 217, Licensing, so as to amend Article I, General Procedures and Regulations, so as to amend §217-2(J) in its entirety as follows:

J. The name and address of the insurance company providing applicant with public liability insurance, policy number, expiration date, and the amount of coverage in an amount not less than \$500,000 combined single limit. A certificate of insurance shall be submitted which evidences the minimum liability insurance requirement pursuant to P.L. 2022, c. 92.

**SECTION 2.** That the governing body hereby amends Chapter 217, Licensing, so as to amend Article I, General Procedures and Regulations, so as to create a new section §217-14, Liability Insurance as follows:

§217-14 Liability Insurance

Failure to comply with the requirements for submitting a certificate of insurance evidencing minimum liability insurance as required under P.L. 2022, c. 92 and §217-2(J) above may subject a business owner to a summary proceeding pursuant to N.J.S.A. 2A:58-10 et seq. whereby the Township may collect a fine of not less than \$500, but no more than \$5,000, against

a business owner failing to comply with the law.

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law.
