WHEREAS, Michael Glock has submitted a request for resignation from the Township as of February 15, 2023; and

WHEREAS, as of the date of his resignation, Michael Glock will have accumulated 25 hours of unused time over the course of his employment with the Township of Little Egg Harbor; and


WHEREAS, Michael Glock is entitled to compensation for a total of 16 hours for unused vacation time in the amount of \$385.12 plus 9 hours of personal time in the amount of \$216.63, for a total payment of \$601.75.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Governing body does hereby accept the resignation and authorize payment to Michael Glock in the amount of \$601.75 for unused accumulated time.
