

**RESOLUTION NO. 2023-106**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,  
COUNTY OF OCEAN, STATE OF NEW JERSEY, ACCEPTING  
THE RETIREMENT OF AND AUTHORIZING THE  
COMPENSATION OF ACCUMULATED TIME TO KRISTEN  
STORY**

**WHEREAS**, Kristen Story has submitted a request for retirement from the Township as of March 1, 2023; and

**WHEREAS**, as of the date of her retirement, Kristen Story will have accumulated 1,070 hours of unused time over the course of her employment with the Township of Little Egg Harbor; and

**WHEREAS**, Kristen Story is entitled to compensation for a total of 480 hours for unused vacation time in the amount of \$33,528.00; 242.75 hours for unused sick time in the amount of \$8,476.83; 14 hours of unused personal time in the amount of \$977.90; 92.25 hours of unused comp time in the amount of \$6,443.66 and 241 hours of workers comp time in the amount of \$16,833.85, for a total payment of \$66,260.24; and

**WHEREAS**, a payment of \$8,500.00 shall be paid in monthly installments beginning March 24, 2023 and continuing until satisfied.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Governing body does hereby accept the resignation and authorize payment to Kristen Story in the amount of \$66,260.24 for unused accumulated time, which a payment of \$8,500 shall be paid in monthly installments beginning March 24, 2023 and continuing until satisfied.
2. That a certified copy of this resolution shall be sent to the Kristen Story, Civil Service Commission and Chief Financial Officer.
