**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY,
AUTHORIZING APPROPRIATION RESERVE TRANSFERS
IN ACCORDANCE WITH N.J.S.A. 40A:4-59**

WHEREAS, N.J.S.A. 40A:4-59 provides that a governing body may within the first three months of the fiscal year transfer the amount of excess appropriation reserves to those appropriations deemed to be insufficient; and

WHEREAS, such a transfer resolution must be authorized by not less than two-thirds vote of the full membership of the governing body; and

WHEREAS, the governing body of the Township of Little Egg Harbor has determined to authorize various transfers of appropriation.
